IMDG Code Course for Stevedores

Introduction:

This course is developed for stevedores to enhance their knowledge and understanding when handling dangerous goods during stevedoring operations.

The successful application of regulations concerning the storage and transport of dangerous goods and the achievement of their objectives are greatly dependent on the appreciation by all persons concerned of the risks involved and on a detailed understanding of the regulations. Therefore training of persons to use the IMDG Code, to understand the nature of dangerous goods for transportation, handling and storage is important.

Objectives:

The purpose of this training is to enable stevedores to have the required knowledge and understanding to competently perform the following functions:

- Classify dangerous goods and identify Proper Shipping Names of Dangerous Goods.
- Mark, label or placard dangerous goods.
- · Accept dangerous goods in transport.
- Prepare dangerous loading / stowage plans.
- Carry dangerous goods in transport.
- Inspect for compliance with applicable rules and regulations.

Course Outcomes:

After successful completion of the course the trainee will have the understanding and competency to safely perform stevedoring duties covering:

 Grouping dangerous goods together based on the hazards they present (classification).

- Storing dangerous goods in packaging's/tanks which are of appropriate strength and which will prevent the goods escaping.
- Using hazard warning labels and other identifying marks to identify dangerous goods in transport.
- Preparing standard documentation when dangerous goods are being transported.
- Applying appropriate segregation to ensure that dangerous goods which will react dangerously when together are kept apart.
- Preparing safe storage plans for dangerous goods on board ship to ensure safe transport.
- Provides emergency response advice for dangerous goods if involved in a fire or spillage.

Requirements:

The candidate should be:

- at least be 18 years of age
- completed a minimum education of Year 10
- be fluent in English both written and spoken
- familiar with the duties of stevedoring operations

Certificates:

The trainee will receive a certificate of competency after successfully completing all assessments for the theory and Practical demonstrations.
